Dear Scholarship Applicant,

At the Smart Start Early Learning Center, we strive to empower the children in our community by providing high quality education and care services. We understand that even though we work to keep our tuition as low as possible for all families, the cost is at times greater than the financial resources available.

By means of generous contributions, the program is able to offer assistance to qualifying families through the Smart Start Early Learning Center Scholarship. The intent of this scholarship is to provide financial assistance to those families that might not otherwise be able to afford the full cost of tuition during a period of financial hardship. At present, the program has funding to award two \$500 scholarships. Please understand that our financial assistance fund is limited, and while all requests are considered, we cannot guarantee assistance to any applicant.

Enclosed you will find a list of eligibility criteria, a checklist for supplemental documentation, and an application form. Applicants must meet all eligibility requirements to be able to apply. Completed applications with supporting documentation must be received by the Smart Start Program Coordinator no later than 4:00 p.m. on the application deadline provided in the box below.

Once your application package is received, it will be reviewed by a panel that includes at least one member from the Board of Directors, the Smart Start Coordinator, the West Point Family Advocate, and the Fiscal Manager. The panel may also include other members as necessary. Please be assured that all committee members will maintain strict confidentiality.

### Eligibility Criteria:

- Must be enrolled full-time with the Smart Start Early Learning Center for at least six months.
- Must show a demonstrated financial need.
- Must be willing to volunteer 30 hours with the program during the award period.
- Must be directly paying for at least 50% of the weekly tuition cost. Clients that receive more than 50% of tuition support for their child(ren)'s tuition from another agency are not eligible to apply.
- Must complete the take home Financial Literacy training or other relevant personal financial management training (approved by the Executive Director).
- Must not be employed by the Parent Child Development Corporation.
- Must not have received an award within the previous 12 month period.

### Application Checklist:

To apply for the Smart Start Early Learning Center Scholarship, you will need to complete the enclosed application and include the following items:

- \_\_\_\_\_ Prior year's tax return or statement of annual earnings;
- \_\_\_\_\_ Unemployment income statements (if applicable);
